#### **Abstrak**

her even her age is about thirty but it seems that she does not have any sign

showing that she is pregnant. In addition, she is very disappointed when she gazes

at her relative's son which is suckling on the breast. Liz dreams like her relative.

She also wants to be like her relative to have a child being able to color her

household. Nevertheless, Liz cannot be pregnant and cannot have a child like her

relative. She is disappointed and somewhat desperate with that condition. Yet, as a

woman, she tries to hold out and not to drag over the sadness. Finally, she is able

to pass it and able to solve it.

More beautiful even than Roman women, to be honest. Italian men
