Data analysis concerns the interpretative technique that focuses on examining data. The main source of this research is the novel Daisy Miller this research is going to answer the research questions what is the characteristic of democracy and Feudalistic is as reflected in Daisy miller novel? And what are the phenomena between democracy and Feudalistic in Daisy Miller novel? From the analysis the author concluded that *Daisy Miller* is a representative of American woman as same as democracy in the American Custom, She is going abroad to Switzerland which is peaceful country inhabited by all kinds of people of different race, ethnic, language, skin color, religion, profession, from all over the world. Henry James as the realist author criticized the condition in his era. Henry James was born in 1843, his parents were Henry James Sr and Mary James. Henry James had three brothers and one sister. Henry James ancestor, William James was an 18 years old Irishman who arrived in America in 1789. According to family legend, the ancestor arrived with a very small sum of money and later gained a small fortune through the establishment of a store in New York. Later, he ventured into banking and the manufacture of salt which paved his way as a powerful man in the upper Hudson area, as a young child, Henry James had only private tutors and never gained any strict education. The year Henry James turned twelve years old his

family moved to Switzerland and later to France and Germany. After the competition of his family's travels, Henry James returned to America and enrolled in Harvard School for a while. He Law withdrew soon after his enrollment because he desired to pursue writing rather than an education. His father's leisurely lifestyle as a traveler and writer allowed Henry James to meet people like Ralph Waldo Emerson and Bronson Alcott. His youthful vears in Europe left a great impression. Later in his life, James moved to England where he established citizenship as a protest against America's failure to enter the war against Germany. James purposely developed his novel with a conscientious slowness and refinement. James was interested in the society of people who possessed of his ideas. Henry James was the first writer to introduce the theme of an American in Europe. Character in "Daisy Miller", Daisy Miller is a young exceptionally pretty, young lady from the United States who shocks the more formalized European society by her spontaneous

- Cultural studies transcend the confines of a particular discipline such as literary criticism or history, it means that analyzes diverse social and political interest and addresses many of the struggles within the current scene.
- 2. Cultural studies are politically engaged. Cultural critics see themselves as "oppositional" to the power structures of society; they question in qualities within power structures, including the seek classroom. and to restructure relationships among dominant subordinated and cultures.
- Cultural Studies denies the separation of "*High*" and "*low*" or *elite* and *popular culture*. All forms of cultural production need to be studied concerning other

cultural practices. A cultural study is committed to examining the entire range of society's beliefs, Institutions, and communicative practices, including arts.

Cultural Studies analyze not only the cultural work that is produced but also the means of production; it means that it has correlated with the Marxism, that shows differentiates of social class. Labor, Land of tenure. He also had shown about materialism culture as the effect of Capitalism which emerged of separated class in society. Socialist Utopia that distinguishes between labor and leisure and makes Transformation in Community. In "Daisy Miller" novel we can get the points of social-life in a certain society.

Besides that, Suwardi Endaswara said: if we analyze the methodology of works art, it is better to analyze the background of the author because the social condition of the author could influence of the works of art. So, many scientists who want to analyze the sociology of literature which correlates between

Winterbourne, who has lived in Geneva most of his life, is both charmed and mystified by Daisy, who is less proper than the European girls he has encountered. She seems wonderfully spontaneous if a little

The following winter, Winterbourne goes to Rome, knowing Daisy to be there and is distressed to learn from his aunt that she has taken up with several well-known fortune hunters and become the talk of the Town. She has one suitor, in particular, a handsome Italian named Mr.Giovanelli of а certain background whose conduct with Daisy mystifies Winterbourne and scandalized the American community in Rome's fashionable society. Mrs. Walker and Winterbourne attempt to warn Daisy about the effect her behavior is having on her reputation but she refuses to listen. Daisy spends increasingly more time with Mr.Giovanilli. Winterbourne begins to have doubts about her character and how to interpret her behavior. He also becomes uncertain about the

nature of Daisy's relationship with Mr.Giovanili. Sometimes Daisy tells him they are engaged and other times she tells him they are not. One night on his way home from a dinner Winterbourne party, passes the Coliseum and decides to look at it by moonlight braving the bad night air that is known to cause "Roman fever" which is malaria. He finds Daisy and Mr.Giovanilli there and immediately concludes that she is too lacking in self-respect to bother about. Winterbourne is still concerned about Daisy's health. However and he reproaches Giovanilli and urges him to get her safely home. A few days later, Daisy becomes gravely ill and she dies soon after, before dying she gives her mother a message to pass on to Winterbourne that indicates that she cared what he thought about her after all. At the time, he does not understand it, but a year later, still thinking about Daisy, he tells his aunt that he made a great mistake and has lived in Europe too long. Nevertheless, he returns to Geneva and his former life"

Henry James as the author describes the social character of American and it is differentiated from Europe.
